THE WHATEVER IT TAKES DEPARTMENT PROVIDES INTENSIVE FAMILY SERVICES TO CHILDREN AND FAMILIES DEMONSTRATING SERIOUS EMOTIONAL OR BEHAVIORAL PROBLEMS. THE FAMILIES SEEN IN THESE PROGRAMS DEMONSTRATE SIGNIFICANT DIFFICULTIES, INCLUDING MULTIGENERATIONAL HISTORIES OF FAMILIAL TRAUMA, PARENTAL HISTORIES OF SUBSTANCE ABUSE OR MENTAL ILLNESS, AND INVOLVEMENT WITH THE CRIMINAL JUSTICE OR CHILD WELFARE SYSTEMS. PROGRAMS IN THIS DEPARTMENT PROVIDE SERVICES TO CHILDREN PRENATALLY THROUGH SEVEN YEARS OF AGE WHO HAVE EXPERIENCED TRAUMA OR DEMONSTRATE RISK FACTORS FOR TRAUMA OR NEGATIVE DEVELOPMENTAL OUTCOMES. UNTREATED CHILDHOOD TRAUMA CAN HAVE DEVASTATING LIFE-LONG EFFECTS THAT IMPACT A CHILD'S PHYSICAL AND MENTAL HEALTH, ABILITY TO GROW AND LEARN, TRUST OTHERS, AND MAKE HEALTHY CHOICES.
