UNTREATED CHILDHOOD TRAUMA CAN HAVE DEVASTATING LIFE-LONG EFFECTS THAT IMPACT A CHILD'S PHYSICAL AND MENTAL HEALTH, ABILITY TO GROW AND LEARN, TRUST OTHERS, AND MAKE HEALTHY CHOICES.
